VIII. Town Manager's Report: Mr. Duty presented the town manager's report for the month of July. Mr. Duty presented the Council with a proposed Brush, Bulk Garbage, and Solid Waste Service Notice and Fee Schedule. No motion was made on the proposed notice and fee schedule.

A. Police Department Report: Chief Mitchell presented the police department report for the month of July. Chief Mitchell informed the Council that the Lebanon Police Department had assisted the FBI on a case involving items being smuggled into prison by a guard. He

advised that his officers had successfully assisted with the arrest of the guard and therefore the Town was granted an \$8,000 seized asset contribution.

IX. Upon motion made by Mr. Boyd, seconded by Mr. Fields, the Council unanimously voted to authorize Mr. Duty to employ Mr. Charles D. Saltz, Jr. as a patrolman on a full-time basis, to include a one-year probationary period, beginning August 10, 2015. Employment will be conditional upon the acceptance of the employee work agreements. X. Town Attorney Report: Mr. Tiller informed the Council that delinquent business license letters had been mailed and provided status updates for upcoming court cases.

XI. Committee Reports and Recommendations:


A. Ms. Jackson, Parks and Recreation Committee Chairwoman, recommended that the Council abolish Ordinance No. 15-1 that requires all dogs on town property and public right-of-ways to be kept on a leash and muzzled and recommended strict enforcement of the Town's leash law.



Mr. Tiller advised that he would research this matter and report back at the following council meeting.
