VII. The topic of Personnel was brought up, no discussion or motion taken.


VIII. The Council discussed getting specs to start on the Gym and wish to invite J. A. Street to the Council meeting for further discussion.


IX. The Council discussed the Downtown Revitalization and want to proceed with street lights & arch.
