E. CARES Act Funds

Mr. Leonard presented an update report prepared by Beverly Stinson the Financial Officer concerning the CARES Act Funds. The detailed report showed the revenue received and all the expenditures for the Town of Lebanon and the Lebanon Volunteer Fire Department. All the funds are exhausted for both the Town and the Fire Department. Mr. Gilmer advised that Ms. Stinson will continue to update these spreadsheets through December 31, 2020 with any item that is related to COVID-19.

Mr. Leonard advised that the Town has \$165,576.83 in an escrow account. Mr. Farmer prepared an updated list of items purchased for the Lebanon Community Center for the amount of \$100,677.10 that has been paid from the general fund. By transferring the \$100,677.10 from the escrow account into the general fund that would leave a balance of \$64,899.73 to go toward the bond payment for the Lebanon Community Center. Mr. Gilmer stated that he agreed with Mr. Leonard regarding the escrow account.
