V. 2017 – 2018 Budget:

VI. Mr. Boyd informed the Council of the need for two additional trucks for the street department. Mr. Boyd explained that the delivery date would be approximately 8 to 12 weeks from the date of purchase and therefore the trucks would need to be purchased as soon as possible in order to prepare the trucks for the upcoming winter. Mr. Boyd presented the Council with quotes received for the two trucks.


Upon motion made by Mr. Boyd, seconded by Mr. Fields, the Council unanimously voted to purchase two Chevrolet ton trucks at the quoted price of \$29,937 from Morgan-McClure Chevrolet GMC, Inc.
